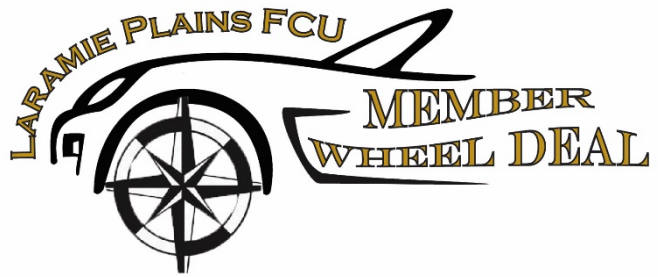

Thank you for your interest in our *Member Wheel Deal Sale!* Attached please find your vehicle registration packet which must be completed and returned to Laramie Plains FCU by 5:00 PM on Monday, **July 20, 2015**.

Space is available on a first-come, first-served basis and is limited to one vehicle per member. A second vehicle may be placed on a waiting list depending on space. Registrations after the **first 25** automobile applications and **first 25** recreational vehicle applications will be placed on a waiting list. If you sell your vehicle prior to the sale, please inform us so another member can fill your spot.

To attract buyers to the sale, Laramie Plains FCU will promote the sale on its website, via social media, on member statements and other marketing materials during the month of July. In addition, the event will be advertised in newspapers and on radio stations during the week leading up to the event. Early registrations prior to July 17, 2015 will be included in advertising on Laramie Plains FCU's website and in newspaper ads.

Day of Sale Information

- Local radio stations will be on-site to promote the event.
- Loan officers will be on hand to provide buyers with financing options.
- You are required to stay with your vehicle for the duration of the sale.
- Bring your lawn chair!
- Concessions will be available with proceeds to benefit Hospice of Laramie.

Attention RV Sellers

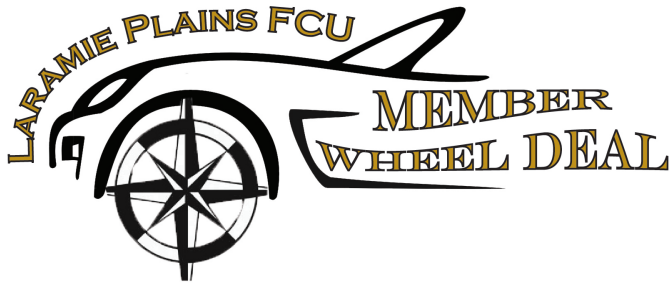
- The designated parking lot for the recreational vehicles is gravel.

6. Vehicle must be in operable condition.

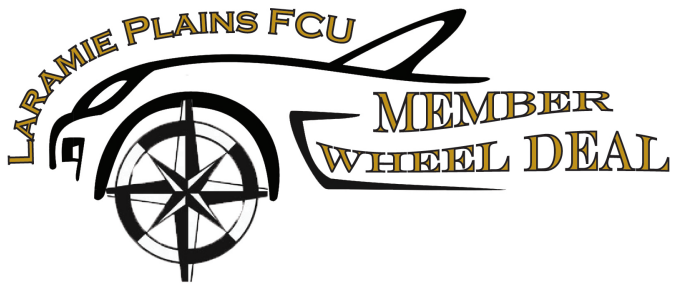
BE ADVISED THAT LARAMIE PLAINS FCU IS NOT A VEHICLE DEALER:
